The next form is the Student Activity Unit which is usually abbreviated as UKM call Indonesian, namely student organisations that are formed based on similar interests, both in the fields of sports, experience, art or others. As well as the Student Executive Board, Student Representative Council whose forms and structures are different in each college. The position of Student Organizations because it consists of various disciplines, the position is in the University/Rector (Susanto, 2018); (Alam, 2016).

Student Organizations are a forum for gathering students to achieve a common goal but must remain by the constitution of the constitution that has been approved by all Student Organizations members.
