Homeschooling for children with special needs is based on structured, patterned, programmed, consistent principles. The success of homeschooling is appropriate supported by an curriculum, adequate facilities and the participation of parents, while the method used is the provision of an environment and facilities that allow for a free learning process for each child. Judging from the theory of school guidance. the implementation homeschooling makes children active in developing their own potential. in Gardner's theory intelligence that everyone's intelligence different. With homeschooling, children's potential can be developed to the maximum so that children will master the fields of interest that will later be beneficial for the child.
