

Guide For Authors

1. Types of contribution

This journal publishes original scientific papers, reviews, and short communication the fields of life sciences with emphasis in biotechnology, molecular biology and biochemistry. Reviews will be written by invitation, however, unsolicited reviews will also be considered for publication if prospective authors first contact the Executive Editor to check the suitability of their proposed subject matter.

2. Manuscript preparation

General. Manuscript should be in English. Manuscripts must be typewritten using word processor package of Microsoft Word, 1.5-spaced with 2 cm margins on all side of A4 paper with a font size of 11 of Arial. Use line number. in Microsoft Word Program, on the Page Layout tab, in the Page Setup group, click Line Numbers, and choose Continous. For original scientific paper, the manuscript should not be more than 15 pages. including figures and tables. For mini-reviews and short communications, the manuscript should not be more than 10 pages. Figures and tables are grouped and put at the end of the manuscript. after References.

Three copies original manuscript and one softcopy file indicated the first author name must be submitted. The Editors reserve to right to adjust style to certain standards of uniformity.

Title. A concise and information title written in a sentence format

Author's Data

- Author(s) full name and The affiliation(s). No abbreviation)
- Full address(s) with postcode, phone, faximile and e-mail address of the corresponding author

Abstract. Abstract should be a brief summary of the paper and should present the most important results and conclusions in no more than 200 words.

Keywords. Three to five, should be supplied after the abstract.

Abbreviation and Symbol. Abbreviation and symbol should be defined at first mention in the abstract and again in the main body of the text and used consistently thereafter.

Introduction. The Introduction is a short section in which the authors should state the reasons for the performing the work with brief reference to relevant previous work.

Material and Methods. The Materials and methods should be detailed enough for readers to reproduce the experiment.

Results. The Results section should be presented as concisely as possible, where appropriate in the form of tables or figures. Full details of replication of results and statistical significance of differences claimed should be given.

Discussion. The discussion section should deal with the significance of the results and their relationship to the object of the work. Comparison with relevant published work should be made and conclusions drawn.

Citations in the text

- If the author's name is James Robert Jones, you would use the surname Jones and the date to cite in the text: e.g. There is some evidence (**Jones, 2008**) that these figures are incorrect.
- If the author's name is part of the statement, put only the year in brackets: e.g. **Thontowi (2008)** has provided evidence that these figures are incorrect.
- If there are two authors, give both, and if you are giving a direct quotation then you need to include the page number: e.g. It is claimed that government in the information age will "work better and cost less" (**Bellamy & Taylor, 1998, p. 41**).
- If there are more than two authors, cite only the first followed by '*et al*'. **Hartati et al., 2008**.

- If an author has published more documents in the same year, distinguish between them by adding lowercase letters: e.g. In recent studies by **Nugroho (2009a, 2009b, 2009c)**.
- If you wish to cite a work described in another work: e.g. **Santoso (2005) as cited by Fuad (2009)** or **Santoso's 2005 study, cited in Fuad (2008, p. 156)** shows that... Then cite Jones in full in your reference list.
- If citing web resources in the text use **Author**, but if not available then use the **organisation** as the author. **Title of site**, only use if there is no author or organisation. If there is no author, organisation or title, **use truncated web address**. You should question if this resource is suitable for academic work.
- If you find information in more than one source: e.g. Several writers. **Nuswantara (2004); Kusharyoto et al (2006); Lisdiyanti et al (2008)** argue...

Acknowledgement(s). State of the grant source. Institution, year and contract) and the person(s) to whom contributing to the work.

References. The list of references should be arranged alphabetically by authors' names. The manuscript should be carefully checked to ensure that the spelling of authors' names and dates are exactly the same in the text as in the reference list. References should be given using the author-date system:

All illustrations should be clearly marked on the back with the figure number. All figures should be in black and white. However, colored figures will be accommodated with the cost will be paid by the authors.

Size of figures and figure legends. Original photographs must be supplied as they are to be reproduced. A scale should be marked on the photograph. Arrow(s) should be given to point certain object. Please note that photocopies of photographs are not acceptable. The figure legends must be brief and self-sufficient explanations of the illustrations.
