Clinical legal education is a progressive educational ideology and pedagogy that is most often implemented through university programs. Clinics are interactive, hands-on classrooms that promote learning by doing.

CLE programs offer classroom simulation lessons based on real-life cases and/or clinic experience involving interaction with real clients. CLE programs are conducted under the supervision of experienced law clinicians and legal practitioners.

CLE students also engage in a variety of community outreach programs including women's groups, support groups for people living with HIV, juvenile detention centers, community centers and other institutions. There, they teach classes that are designed to help people understand and access their legal rights and services. Areas of teaching often include: the rights of stateless persons; criminal law; family law; consumer protection 1 aw; land law; housing rights law; HIV/AIDs and the law; healthcare rights; prisoners' rights; juvenile justice; employment and labor law; and basic life and other skills.
