## **Abstract**

The data are utterances containing indirect promises that are produced by the candidates at debate program entitled "*Jakarta Memilih: The Final Round* on Metro TV" that's held on 16 September 2012. This research reveals that there are 25 utterances include in indirect promising acts. From those findings, the researcher finds 23 utterances realized in declarative sentences and the other uses imperative and exclamative sentences. Besides, the researcher also finds 18 data of 25 utterances fulfill the condition of promising acts and 7 data do not fulfill the condition of promising act.
