Women live in stressful times to show how their bodies look. Driven by guilt and shame, many women castigate themselves by doing strict diet and even doing a plastic surgery to achieve the standard of beauty without thinking about the dangers that will happen to their body. The standard of beauty impacts on Louise's life within a short story titled *The Fat Girl* by Andre Dubus. Standar kecantikan memaksa kaum perempuan untuk mengikuti keinginan masyarakat. Standar kecantikan di Amerika dan sebagian besar masyarakat barat yaitu perempuan bertubuh langsing dengan mata yang cerah dan rambut lurus panjang. Jadi mereka harus memenuhi apa yang diinginkan oleh standar kecantikan. Meskipun dapat merusak, tetapi secara sosial, bahkan moral, diterima untuk mendukung standar kecantikan.
