Since, the minister of education and culture stated that all he activity of teaching and learning should be done at home by online learning, then it gives some positive and negative impact. The negative impacts are; not all teachers, students, or parents have a facility to access internet, nor use IT well, for example theachers who are old or students of pre school still need their parents' help. Then, not all parent can earn money to buy internet quota. Moreover, the positives impacts are; the students become familiar to use IT and it is safe for them to avoid covid-19 outbreak by studying at home.

COVID-19

The outbreak of covid-19 had frightened people all over the world. What is Corona Virus Disease 2019? It is a name of a new virus that never exist before. This virus comes from Wuhan, China. It spread fast to all over the world even to Indonesia. In the beginning of 2020. On March, 2020 Indonesia report there were 2 person got positive of Covid-19. Unfortunately, up to now November 2020 there are thousands of people in Indonesia attacked by covid-19. The signs that someone attacked by covid-19 are fever, cough, and interference of respiratory system. The incubation time of this virus approximately 5-6 days and longer incubation 14 days.

There are almost no activities outside home, especially in a place that make crowd, such as market, mall, office, school, park, factories except hospital as the important place for recovery patient of covid-19. Everybody has to isolated him/herself to stop spread of the virus getting wisely. It paralyzed all aspect of human life such as social, culture, health, economic, law, and also education. The new year academic study for every unit of education of pre-elementary, elementary, junior high school, and senior high school start from July 2020, but for those who are in the yellow, orange, and red zone forbidden to do study face to face at school. They should continue to study at home.

E-LEARNING

In terminology e-learning known as online learning, distance learning, or in network learning. According Ainurrahman in Silahuddin (2015) that the development of e-learning technology has given new nuance in the education aspect. Conventionally, in the past time, teachers and lecturers did the teaching and learning activities by gathering the students in a certain place or room in the same time, that condition today has enriched by the development of technology which is not obliged the students stay together in by the limitation of time and place.

Considering the importance of study even in the covid-a9 outbreak so, elearning in online network is the main solution for students and teachers to do teaching and learning activities at home during the pandemic of covid-19 time. Since everybody should do social distancing and cannot easily get contact each other all the activities in the classroom move to home. Students learn by themselves using social media connected to the internet. Clark & Mayer in Hanum (2013) stated that elearning is one of a learning model facilitated and supported by technology of information and communication. Elearning has some characteristics: (1) It has a relevance content with the goal of learning; (2) It uses instructional method for example display of models and exercise to improve learning activities; (3) It uses medias such as words and pictures to

deliver learning materials; (4) It is possible that learning directly as teacher centered (synchronous e-learning) or it designed as independent learning (asynchronous elearning); (5) It builds understanding and skill related to the learning's goal whether individually or improve group Based on Rusman, et all in learning. Hanum (2013), e-learning has characteristics such as; (a) interactivity; (b) (c) independency; accessibility; (d) enrichment.

Teachers send learning activities through social media internet or application such as whatsup group, youtube, google classroom, edmodo or meet the students in zoom meeting. By whatsup, teachers send message or pictures about the assignment what they have to do or teachers explain the material alone in the classroom and make a video of it then send it to the whatsup group. Some teachers also send a video of learning by youtube. In this case, students can play more time the video to refresh their mind. Moreover, teachers are able to explain the material and meet the students using google classroom, edmodo, or zoom meeting helped by their parents at home. Unfortunately, not all students can access this facility through internet. There are many reason such as, they have no facility to access it at home, they have to wait their parents for help because their parents still work, or they cannot access it because there is no fee to buy internet quota. As we know in Indonesia not all parents are able to earn money for internet access.

Students wait learning activities from their teacher at home. It make them easy to do the assignment or watch teachers' explanation without time and place limitation. Teachers give them deadline time to submit the assignment such as a day, two days, or three days to give a spare time to students to do a lot of assignments. To make an interesting elearning based on Purbo in Yazdi (2012),

there are three obligatory condition in design e-learning for online learning; simple, personal, and fast.

E-learning or online learning should be simple to make the students easy do the task. In giving exercise, the command in the online form should be make as easy as possible so that the students could understood what to do without learn how to operate the command. Then, it should be personal to make the students easy do the task or ask something personally to the teacher and also as the opposite the teacher can contact the students personally if there is something wrong with the task. The last, it should be fast means the respond of the students task should be fast as possible in order to make the students get the feedback from the teacher.

VIRTUAL CLASSROOM VS REAL CLASSROOM

For a long time teaching and learning process means meeting teachers and learners in the classroom. Conventionally, classroom is a place for students and teachers do learning activities. They have to meet and sit together in the same time. Unfortunately, the rapid changes of a situation and condition at the end of April in Indonesia and also all over the world force the students to study at home.

Virtual classroom should not have big difference with real classroom or training room. An effective class according to Porter in Darmayanti (2007) is able to:

- 1. Preparing tools needed by learners
- 2. Creating conducive atmosphere in learning
- 3. Creating togetherness between learners teachers and transfer information and ideas
- 4. Making the learners possible to do experiment and finish their task
- 5. Developing a mechanism to evaluate learners' capability

6. Making available a comfortable and safe place to study

Virtual classroom should facilitate student's need like in the real classroom but it will make them more independent in learning because it is not teacher centered like in conventional classroom. The access of internet should in a good network to make a good transfer of knowledge.

However, real classroom or face to face learning usually asked students and teacher to meet in one place and in the same time. Students need teacher to explain the lesson and wait some instruction to do some tasks. It is limit by time duration in each lesson. The students also have to bring some books for their need in learning.

Moreover, sometimes in conventional class teacher is a center of a learning if there is no right method. Students depend on the teacher to absorb knowledge. On the other hand, in virtual classroom can minimalize it.

DISCUSION

- Since the students have to study at it home, make parents more protective to their children to eat healthy food to keep their immune in good condition in order to avoid covid-19 outbreak.
- It also save fee of transportation for parents because their children do not have to go to school.

NEGATIVE IMPACTS

According to Aji (2020)obstacles in making the teaching and learning by online learning effective, such as:

- Some teachers and students lack of mastery in IT because not all teachers master how to use IT especially they are who are old and never use and know about IT. Also, for the students in the early age of pre-school or elementary school that still need their parents help.
- The limitation of facility such as laptop, computer, or cellular phone because not all teachers and students have them.
- The limitation of internet access, especially for teachers and students who live in remote area. It will make difficult to do online learning.
- There are some teachers, students, or parents who are lack in preparing fee to access internet to online learning

- because not all teachers, students, or parents are affordable to buy internet quota. Some of parents have to lost their job during pandemic of covid-19 and they cannot earn money anymore.
- There are disadvantage for the students in assessment aspect because there is a new way in teaching, learning, doing exercise, and exam. It may some mistakes in giving score from teachers to the students. Delivering material and assessment in face to face learning way different with online learning.

CONCLUSION

Since covid-19 outbreak happen suddenly at the end of April in Indonesia and over the world, all aspects of human life got the impact include education aspect. The minister of education and culture Nadiem Makarim ordered the teaching and learning process done at home. Most of all students in Indonesia have to study online from home.
