# Utilization SAW Method to Choose Goods Suppliers at PT.King Computer

#### Abstract

The operation of a good system in a company is inseparable from the support of business partners, but it is impossible to obtain if the partner or supplier of goods does not work as the target of the company itself. Given these problems, it is deemed necessary to create a DSS system that can assist directors in determining suitable suppliers to work together. In making this SPK, the SAW method starts from the selection of types of goods, selects criteria and sub-criteria, and determines the weights of each criterion. This study produced an SPK, with six main criteria and their respective weights, based on the criteria entered and processed in accordance with the rules of the SAW method, CV. Eka Makmur was chosen as the most suitable recommendation to become a supplier for all in one PC items. At the testing stage, three methods have been carried out namely black box, output testing, and user acceptance test.

# 1. INTRODUCTION

The company is an organization that aims to create wealth through the businesses it creates. To be able to operate requires a good and comprehensive system that starts from strategic planning to the evaluation stage [1],[2].To achieve the goal the company must create a good system that consists of several functional components that are interconnected properly [3].Problems experienced by PT. King Computers is often the case of delays in shipping stock of goods caused by the negligence of the company to determine a good supplier so that not infrequently resulting in losses, it is deemed necessary to create a system that can really help the company's management in choosing a supporting company or supplier. Decision support systems using the method of simple additive weighting (SAW) is a form or way to overcome these problems.

In the development of information technology decision support systems have been made with a variety of methods, as well as different objects. Research on employee performance appraisal uses the simple additive weighting (SAW) method. The study states that the SAW method is very well used in decision making, but in this study, there are some weaknesses including testing not done in detail so there is no data that clearly proves that testing has been successfully carried out[4].

Decision support system research on acceptance of venture capital loans at BPR PMM Bank concludes the SAW method used has similarities between manual calculations and the final results of the application that has been designed, but in this study has the disadvantage that testing is not found in the paper, so there is no proof of conformity between manual counts and decision support systems [5]. Another study using the SAW method is determining the location of disaster logistics in the city of Jakarta. The research resulted in mapping the location of a disaster warehouse to conduct first aid for flood victims, there are eight criteria to determine the location of a disaster emergency warehouse, this research has a weakness that has not been applied into the application decision support system and only in the form of design [6].

Another study that uses the SAW method that discusses the selection of Bidik Misi scholarship acceptance of this research concluded that the SAW method can work well in the ranking [7]. The SAW method is also used in research that discusses the recruitment of new employees at PT. Warta Media Nusantara, in this study also states that SAW is suitable to be applied in making a ranking, but this research has not been implemented into an application. [8].

### 2. RESEARCH METHODOLOGY

#### 2.1 Research Flow

This study has several important steps that appear as in Figure 1 research flow, making research flow aims to provide an overview for the readers so they can understand the steps taken in this study.




Figure1Research Flow

There are six important steps in this research, the first stage is the study of literature, the step is to study matters related to the research topic, while the sources of literature in the form of papers, journals, thesis research results, proceedings, archives and articles that have the characteristics or the similarity of topics discussed in this study. In the second stage, the identification of the problem to be solved or given a solution is done. After further identification in the third stage, the researchers collected data and information sourced from books or from PT. King Computer. Furthermore, in the fourth stage, data processing is carried out by following the rules in PT. King Computer and adjusted to the rules of the method used that is the SAW method it aims to make it easier to move data into the prototype that was made. The fifth step is to design or create a prototype that is used to prove the manual calculations that have been made. The final step is to test the suitability between manual calculations and DSS.

#### 2.2Simple Additive Weighting (SAW) method

The SAW method has a basic concept of finding the number of ranks for each alternative and for all attributes and requires normalization of the matrix, the SAW method is able to choose the best alternative from a number of alternatives based on predetermined criteria[9][10][11][12].

The final result of the SAW method is ranking each weighted value to obtain wisdom or recommendations that serve as a guide or guide in making a decision.

# 2.3 System Design

# a. Data Flow Diagram

Data flow diagrams are data intended to describe the stages or processes that occur in the system that is being designed or developed. By using the DFD model the flow or flow of data can be detected easily. In the use of the DFD model starting from the context diagram then the tier diagram, level 1 diagram to the detailed diagram, this can be conditioned by the complexity of the Decision Support System developed[5], [13]. DFD level 1 can be seen in figure 2 Data flow diagram.




Figure2Data Flow Diagram Level 1

In Figure 2 illustrates the data flow that occurs in the decision support system application, an admin can perform the create, read, update and delete (CRUD) functions on the SPK, data that can be processed such as login data, item data, criteria data, weight data, then the system can send the processing results of each data that has been inputted into the system, while the data sent by the system to the admin can be in the form of visual appearance or results that can be printed.

# b. Database Design

The database is a collection of data that are interconnected or related to each other, stored on computer hardware and used by software to manipulate it. [14][15][16]. The database design in this decision support system can be seen in Figure 3.




Figure3Design of Decision Support System Database

Figure 3 illustrates the database design with 8 tables used in this CMS, including user tables, tale barang, table bobot\_kriteria, table nilai\_supplier, table supplier, table kriteria, table nilai\_kriteria dan table hasil. Of the eight tables, seven tables are related, while one table stands alone, namely the user table. Table barang has*primary key*(PK) id\_barang which is related totable bobot\_kriteria, table nilai\_supplier andtable hasil,table suplier related totable hasil dan table nilai\_supplier melalui id\_supplier as*primary key*. Table kriteria pass through id\_kriteria as*primary key*related totable bobot\_kriteria, table nilai\_supplier pass through id\_nilaikriteria as *primary key*.

#### 3. RESULTS AND DISCUSSION

The success of a company is inseparable from the partners of the company itself, in this case, the supplier or supplier of goods, profits or profits can be obtained to the maximum if all partners work well, it is definitely the hope of all company owners.

Therefore a decision support system is designed by considering various criteria in accordance with the wishes of the company itself, in order to assist policy makers in determining the best supplier.

#### 3.1 Types of goods

The types of goods that will be sent by the supplier can be seen as shown in table 3.1 Types of Goods.

Table 3.1 shows the types of goods to be sent through suppliers including laptops, allin-one PCs, and monitors. Of the three types of goods are electronic categories.

3.2Determination of Criteria

The criteria are determined based on the needs of the company and in Table 3.2 List of criteria has been made according to the needs.

Table 3.2 lists the main criteria consisting of speed of delivery, discount, service,
guarantee, authenticity of goods and payment term, from the six criteria chosen because they are
considered the most suitable for current needs.

# 3.3Weight Determination

The determination of weights is made based on a level of importance of the criteria determined into fuzzy numbers which can be seen in Table 3.3 Value Levels.

Table 3.3 explains that there are five levels of weights used in this decision support system, and have been converted into fuzzy numbers, 0.00 is a very low value, 0.25 is a low category, 0.50 is a middle category, a value is 0.75 with a high category while 1.00 is a very high category.

After determining the criteria and the next level of determining sub-criteria to provide a level of value for each predetermined criterion, it can be seen in table 3.4 list of sub criteria.

In table 3.4 explains each criterion and its value given by companies that have been adjusted to the needs in the field, for example, the discount rate is given a value division of four categories, i.e. if there is no discount then the value is 0.25, if the discount is 1% -10% then given 0.50 value if the discount is 11% -20%, then a value of 0.75 is given, whereas if the discount exceeds 20% then a value of 1.00 is given.

#### 3.4Calculating Values Based on Weight and Criteria

To determine the value or rank of each supplier is given a weight according to the rules that have been made, it can be seen in table 3.5

Table 3.5 shows the value of each supplier in each category, for example, CV. Brother Two on the delivery speed criterion has a value of 0.25, the discount criterion has a value of 0.75, the service criterion has a value of 0.75, the warranty criterion has a value of 0.75, the authenticity criterion has a value of 0.5 and on the payment due criteria has a value of 0.5. Normalization is done to obtain the ranking.

In Figure 5 is a module that can be used to manage supplier data, a user can perform the create, read, update and delete (CRUD) functions of supplier data needed by the company, the supplier data module has been inputted by several suppliers which are usually the company's choice such as CV. Eka Makmur, CV. Brothers and sisters, CV. Saudara Dua, CV. Surge and several other suppliers.

The supplier data that has been inputted by the user can then make the specified criteria in accordance with the needs of the company and in the decision support system that has been designed, the criteria have two characteristics, namely, cost and benefit. The criteria module can be seen in Figure 6.

In Figure 6 explains the criteria used in the decision support system that has been designed, there are six main criteria, namely delivery speed, discount rates, service, guarantee, the authenticity of goods, and payment tempo. In figure 7 the sub criteria data module explains the level of value that depends on the needs of the company, for example, the sub criteria data module has been solved from the main criteria of speed of delivery into four parts, namely 1 (one) day given a value of 0.25, 2-7 (two to seven) a day is given a value of 0.5, 7 days - 1 (one) month is given a value of 0.75, and if it exceeds 1 (one) month a value of 1.00 is given. in full the values and sub criteria can be seen in table 3.4.

To determine the value for each criterion, a user can access the weights module, which looks like in figure 8.

After giving weight to the items that will be ordered, then weighting the suppliers in accordance with the data owned by the company, while the assessment of the supplier can be seen in Figure 9.

After all the data is inputted then the user can access the results form to obtain wisdom or recommendations from the decision support system, while the recommendations from the SPK that have been designed can be seen in Figure 10.

Figure 10 provides recommendations or wisdom based on data that has been input into the system and processed using the Simple Additive Weighting (SAW) method by selecting all in one PC items and four suppliers, with different values, CV. Eka Makmur as the best supplier.

# 3.6Testing

Testing is a proof of the steps of manual calculations and system calculations, in addition, testing is also done to find out whether the decision support system can work well. *a. Black Box Testing* 

Black box testing is done with the aim of knowing the functionality of the SPK that has been designed, testing is carried out on all modules in the decision support system. The results of testing with the black box method can be seen in table 3.6

Table 3.6 is the result of testing using the black box method, each module is tested for functionality, the testing is carried out in detail but the data displayed is only partial and focused on the most important parts.

# b. Output testing

Testing output is a form of testing that matches manual calculations and the final results of the SPK that have been designed, in this test will get results between failing or succeeding, meaning that if the data processed through Microsoft Excel and SPK has the same results then the test is declared successful or valid whereas if the data processed is not the same then the test is considered a failure or invalid. The results of testing the output can be seen in table 3.7.

In testing the output contained in table 3.7 by selecting the type of goods all in one PC, with six main criteria and weights determined as in the table, between manual and system calculations have in common so that the test was declared successful or valid.

User Acceptance Test aims to find out whether the decision support system that has been designed can be put to good use by the user, while the User Acceptance Test results can be seen in table 3.8.

In table 3.8 User Acceptance Test conducted on five users by giving questions related to the system with very true criteria (SB), true (B) neutral (N), incorrect (KB) and incorrect (TB). From the five respondents obtained a very correct percentage of (SB) 80%, correct answers (B) 16%, neutral answers (N) 2%, incorrect answers (KB) 2% and incorrect (TB) 0%.

#### 4. CONCLUSION

In this study, researchers can draw some conclusions including the following:

- 1. By utilizing the SAW method to design a supplier selection decision support system, it is very good because it can provide the best supplier recommendations based on the criteria and weights that have been inputted on the system.
- 2. With the criteria and the weight that has been entered into the system, from the four potential suppliers selected CV. Eka Makmur is the best recommendation for PT. King Computers to be chosen as a supplier.
- 3. In this research, 3 testing methods have been carried out, the first black box method testing of 6 (six) conditions displayed all successfully performed, the output testing method between manual and system calculations has the same value so that it is declared successful or valid, and user acceptance testing get a very correct answer as much as 80%.

# 5. SUGGESTION

In this study the authors provide several suggestions that can be done by subsequent researchers in making decision support systems, especially on the use of simple additive weighting (SAW) methods, as for the suggestions given are as follows:

- 1. To better know the wisdom accuracy of the SPK, it should be used in combination with other methods, so that the results of the SPK can be compared.
- 2. Testing decision support systems can be added to several testing methods not just black boxes, output testing, and user acceptance tests.
