Abstract

Acts of violence against children is a behavior that is wrong whatever the reason. Because acts of violence against children have a bad impact on children's emotional, psychological growth and development, to the formation of children's personalities that are not good. During the process of implementing online learning which is completely done at home. The family is the main key in carrying out the role of education as a right that must be given to children. The condition of learning loss in elementary school students that occurs results in reduced children's potential and abilities. This study was conducted to determine the interactions that are built in the family during the application of online learning. To find out acts of violence that can be carried out in the family and the direct impact on children. Through descriptive qualitative research in explaining phenomena and triangulation of sources as a method in obtaining data that actually occurs in the field. The results of this study indicate that parents have difficulty in dealing with the implementation of online learning, which often encourages them to be emotional and take acts of violence verbally or even physically. This results in children not getting the maximum learning process at home.

INTRODUCTION

In the COVID-19 pandemic situation, with online learning methods and various limitations faced. Creating social problems occurs in students, when facing a new education system through online learning methods. Reported from the Ministry of PPA. As of August 2020, there have been more than 4,859 cases of child abuse reported with a total of 5,048 child victims. This note is a concern for the government where the numbers show an increase in violence against children in the midst of the Covid-19 pandemic situation.

The impact of the COVID-19 pandemic has caused an education crisis all over the world. Referring to the publication of the UNICEF journal in collaboration with UNESCO & The World Bank, 2021 stated that more than 1.6 billion students were affected and this pandemic exacerbated inequality in the world of education. Limitations in the learning process cause difficulties that can result in learning loss ¹.

When the learning process cannot run optimally, it will affect student learning outcomes that cannot be maximized. It can be understood that this results in the quality of human resources due to lost opportunities in accessing education or learning systems that are not running optimally. Referring to a similar case in 1916 the polio pandemic resulted in school closures which could have a long term negative impact on children's educational outcomes such as reduced school achievement and students' cognitive skills. Although the current conditions and situations are different because there have been advances in information technology that have developed. However, in the implementation of the online learning system, the family has a very important role in creating a conducive learning situation. In providing infrastructure to support online learning activities for each child in order to achieve maximum results. But unfortunately there are still many Indonesian households below the poverty line and the level of parental education is low. According to BPS data in 2020, the number of poor people at the provincial level in Indonesia is still high, with a percentage of 10% of the population. This shows the gap in access to online learning services that can be accessed between students from prosperous families and students from preprosperous families. Various indicators of family background affect the quality of education received by children during the online learning process, such as: education, insight, and family

Violence against children occurs in various forms, physically or verbally. This has a negative impact on the condition of the child's development directly on the current or future condition of the child. Child abuse is a condition where children have an uncomfortable place, are humiliated or threatened. It was conveyed directly when conducting field observations by children as respondents in this study that during online learning the resource persons conveyed that they were uncomfortable, not happy, felt bored doing learning at home. Supporting this statement, it was stated that they often experienced pressure from their learning companions when the learning process took place at home such as: nagging, harsh words and/or labeling as stupid children.

RESEARCH METHODS

The method used is to reveal how students' families accompany distance learning that lead to a tendency to violence against children. This research was conducted with a descriptive qualitative research method. ³Qualitative studies are conducted to describe research problems through exploration of social concepts and phenomena to investigate a research topic. Qualitative methods as research procedures that produce descriptive data in the form of written words spoken from people and observable behavior ⁴.

That the qualitative method is a research method based on the philosophy of postpositivism, used to research on natural objects, where the researcher is the key instrument, sampling of data

As one of the roles of the family in carrying out religious functions, it also cannot impose its will because religion cannot ignore the value of tolerance by respecting various religions that are held as beliefs in society. Based on the research results, the family as the first educator for each

In the theory of symbolic interactionism, it is explained that every social action carried out by each individual occurs through a process. Analyzed in the theory of symbolic interactionism, it cannot be separated from Herbert Mead's view that every action of a preference that comes from society will then cause thoughts in society. In this view, preference is an impetus in the behaviorism approach as a stimulus. As an opportunity or opportunity to take action, it can be underlined that this is different from coercion in carrying out an action that is mandatory.

The process until social action is carried out by someone in the theory of symbolic interactionism is distinguished by several stages, namely Impulse as the first stage for individuals to get a stimulus to carry out an instant reaction or consider a certain situation. Second, perception is the stage where the actor will seek or react to the stimulus that is obtained. This is through the process of analysis through the process of seeing, hearing, and understanding what is happening. In the process of one's perception is strongly influenced by how insight, knowledge, and critical thinking skills to control how the influence of the stimulus will affect the next stage. The third is manipulation, which is the stage when a person manages an event or stimulus that is obtained with various abilities to analyze further about the risks, certain possibilities that must be borne. Finally, settlement is the stage of a person in drawing conclusions until he decides on a choice in what form of social action.

The family is the smallest group unit in society consisting of husband, wife, children who are formed in certain roles that are already attached. They live in the midst of society's social life and cannot be separated in terms of social influence, cultural environment, and various other indicators that influence how social actions are formed by each individual in social relations between family members. Violence in the online learning process that takes place in the family forms a variety of stresses that arise due to the failure to adjust to new conditions, namely online learning that must be carried out by members in the family. Violence in the family arises from various aspects that occur. that the stages in acts of violence can be linked appear to be linear, but that they are as an interconnected process occurring organically influencing one another.



Impact of Violence on Children

Violence against children has a tremendous impact on the growth and development of children. Thus this behavior is opposed by all parties, the state protects every child's rights and regulates the child protection law. Law No. 35 of 2014 as an amendment to Law No. 23 of 2003, Article 9 confirms that every child will get protection in the education unit from sexual crimes and violence committed by educators, education staff, fellow students and/or other parties. other. Furthermore, in article 69 concerning child protection which states that protection for children who are victims of physical and psychological violence as referred to in article 59 paragraph (2) letter (i) is carried out through socialization efforts regarding the provisions of the law as state guarantees in protecting every child's rights. .¹⁰

In understanding acts of violence, we can interpret from Fashri, 2007 in Bordiue, 2012 saying that violence can be interpreted as an actor's action which can be discussed from biological, physiological and psychological aspects. This means that violence is not solely based on the actor's actions on biological impulses. But it is also influenced by the existence of structures that play a role in producing violence. In the theory of symbolic interactionism presented by Blumer, social actions carried out by individuals cannot be separated from general actions and units to describe interactions that develop into very complex. Where it forms the character and interpretive in society. Then how violence can occur is viewed in the theory of symbolic interactionism. Where each individual or action has a meaning for a certain symbol. Parents in the family are the main force who has power over their children. Then what is the meaning of parents who have interpretative rulers over children. Underlying various actions taken by parents to children as owners of "power" and authority in educating children. Regardless of the way in educating that is wrong, right or not right.

In Law No. 35 of 2014 guarantees Child Protection which is defined as all activities carried out in order to guarantee and protect children and their rights so that they can live, grow, develop, and participate optimally in accordance with human dignity and protection from violence and discrimination. We can understand that the protection of children from acts of violence is an action taken to fulfill human rights. As a protection for every child to get their rights as human beings in

Described in the results of the study above, it shows that the family is not able to provide good educational facilities. Where the implementation of distance learning leads to acts of violence against children. As well as causing negligence in providing a proper learning space for children. As an indirect form of violence, it means that children are not given the right to education as a basic right in honing their potential and abilities. Bordiue conveys the concept of symbolic violence which is interpreted by applying a social meal and a representation of reality that is internalized to other actors as natural and valid8. The symbolic violence conveyed by Bourdue is an indirect form of violence. This is done through the mechanism of hiding the violence that is owned into something that is accepted as "what should have happened".

CONCLUSION

With various forms of violence against children occurring in the home during the online learning process. Generate forms of direct violence (direct violence) and indirect violence or alienative violence by revoking the right to education for children.

Alienative violence arises when online learning causes negligence in providing educational facilities for children as a right that must be protected. This happens due to various factors that must be faced by children's learning companions. Generating stress in dealing with children affects acts of violence directly. Resulting in the learning process that cannot be given properly which must be obtained by the child. Learning assistants often ignore the learning process provided, but online learning is only result-oriented. So that what happens is the neglect of the right to education that they should get. To increase their understanding and knowledge of their potential, there has been direct violence during the implementation of online learning. With different levels of violence, three students of whom have lower achievement levels are more likely to experience acts of violence when implementing online learning at home.

Children with low learning motivation will tend to experience more extreme violence. Violence that occurs is not only verbal violence, namely violence that occurs using words that are

intimidating, rude, threats that cause fear or discomfort by children. In addition, acts of physical violence can occur such as direct beatings with their hands or using objects around them such as pillows, clothes hangers. This is due to several factors that influence the situation of learning companions to commit acts of violence. Consciously, the learning assistant admits that it is difficult to accompany the child to study because they already have the same busy schedule that is equally important and cannot be left behind. On the other hand, they have to deal with children who are difficult to do school assignments so they really need extra patience.
