This movement is an activist movement aimed at anti-racist advocacy and protest that was formed on July 13, 2013 or about 6 years ago. Location International (mostly in the United States) and ofcourse this movement was of course formed by strong people like Alicia Garza, Patrisse Cullors, Opal Tometi. This movement began in 2013 starting with the #BlackLivesMatter hashtag on social media after the release of George Zimmerman in the shooting death of African-American teenager Trayvon Martin in February 2012, due to the many acts of police brutality in America that caused many people to kill Africans. nationally for street demonstrations.

This movement received international attention and made national headlines during George Floyd's global protest in 2020 after Floyd's death by police officer Derek Chauvin in Minneapolis, Minnesota. The appearance of the phrase "All Lives Matter" as a form of response to the Black Lives Matter movement was rejected because it did not fit the understanding of "Black Lives Matter" and there was also a hashtag formed by police supporters namely Blue Lives Problem, not only that but many more forms of response to rejection the organization even some civil rights leaders disagree with the tactics used by Black Lives Matter activists.

We think different skin colors are examples that we often see in Indonesian lives, where the whiter your skin color, the more people will praise you while the more your skin color, you will not be separated from bullying. As in the Miss Indonesia event, as we know, there are not many black people, so maybe at most only two black people can enter the event. This is in our opinion only a small part of the form of racism that is not seen in Indonesia, but currently no one cares, racism will become a daily habit.

Unconsciously we always differentiate people based on their skin type, for example in our government always choosing a member from the group with the same skin type as us. Punishment also becomes unnatural when dealing with certain groups of people such as Papua.
