RESULTS AND DISCUSSION

But a teacher's duty is to educate and be able to communicate well with students both in the learning process and outside of class time.

Teachers not only need to hone social competence to students, but also to fellow teachers and school principals. Social competence among fellow teachers is also needed to agree on things to be done for students at school. The teacher's social approach to students is also needed, such as how the teacher communicates with students, solves problems experienced by students and how the teacher tells students' mistakes and follows up on them.

Regarding students who have problems, if the problem is considered mild, then it will be followed up directly, for example speaking that is not supposed to, then punishment can be given immediately. If it is related to a problem that is considered severe, then the approach taken is to talk directly with the parents to discuss the child's problem. Then it is necessary to give advice so that the child realizes that what he is doing is wrong. Then appreciation or rewards that can be

given to students to motivate these students. The approach taken is to help students to be more focused in carrying out all activities at school.

Regarding the problem of broken home. Nowadays, there are many things related to a broken home, and from that problem, the biggest impact can be seen on children. Of course, children can have different personalities and may have a negative impact on increasing student achievement. So the approach taken is to talk to the parents, then make an agreement with both parents. This responsibility must be an agreement between the two so that the problem does not have a negative impact on students. For the problem of bullying, more or less every school must have bullying problems, both in the form of small bullying and big bullying which have an impact on the mentality of students. So the social approach that must be taken by the teacher is to communicate with victims and perpetrators. To the victim, the approach taken must be softer about the causes of the problem from the student's point of view so as not to be pressured. To the perpetrator, the approach is taken in a more assertive way related to the cause of the perpetrator doing this, and following up on the consequences of what he did.

CONCLUSION

In general, this study shows that SMP IT Nurul Fadhilah teachers already have social competence, aspects that form the basis of teacher social competence have been applied to how to follow up on student problems, one of which is with communication. Because communicating with students is important for a teacher to see the potential and development of student achievement.
