Both types of structure have their respective advantages. The former is easier to write about, while the latter is generally clearer as it that similarities ensures the differences are more explicit. The second is block structure means that the comparisons and contrasts are explained first, then information about the object that is comparing or contrasting is explained afterwards, the advantage of this structure is that it is easy in writing. whereas the point-by-point structure means that each object that is compared or contrasted is immediately follow by additional information in the form of similarities or differences in the objects above, the advantage of showing a more explicit comparison and contrast.
