

GUIDELINES FOR AUTHOR

A. Introduction

Publishing two times a year, ie Issue 1 Issue 2 in June and October and already have a registration number p-ISSN: 2442-5133 and e-ISSN: 2527-7227 published by the Indonesian Institute of Sciences (LIPI). Since 2017, Al Ibtida: Jurnal Pendidikan Guru MI in cooperation with the Association of Lecturers PGMI Indonesia.

Al Ibtida: Jurnal Pendidikan Guru MI has been indexed by Directory of Open Acces Journals (DOAJ), Crossref, Indonesian Publication Index (IPI), Moraref, Indonesian Saintific Journal Database (ISJD), Google Scholar, Bielefeld Academic Search Engine (BASE), Mendeley, Citeulike, WorldCat, Academia.Edu, Academic Resource Index, Scholarsteer, Directory of Research Journals Index (DRJI), Universal Impact Factor (UIF), Indonesia One Search, and others.

B. The Guidelines for the Manuscript

1. Articles which will be submitted in Al Ibtida: Jurnal Pendidikan Guru MI is *the result of the research* in the field of basic education.
2. *Title*, Title of the article about the 15 words, give an overview of research that has been done (*short, straightforward, and informative*), times new Roman 12, spacing 1, spacing after 6 pt.
3. *The author's name*, complete without a title written and typed below the article title. If the author of more than one person, then added the next row.
4. *Originally institutions / agencies*, written in the name of the institution where working (Studies Program, Faculty, University). Example: Jurusan Pendidikan Guru Madrasah Ibtidaiyah, Fakultas Ilmu Tarbiyah dan Keguruan, IAIN Syekh Nurjati Cirebon.
5. *Email address*, write the email address is still active and is written under the origin of institutions / agencies.
6. *Abstract*, written in two languages, namely Indonesian and English. Abstract contains a brief description of the problem and research objectives, methods used, and the results of research. Abstract writing pressure primarily on the research results. Typing abstract done with a single space with a narrower margin of right and left margins of the main text with approximately 200 words.
7. *Keywords*, Number 3-5 word keyword.
8. Systematics of writing the article *the results of research* are: introduction; research methods; results and discussion; conclusions; bibliography.

C. The Guidelines for Citation and References

1. Author should cite several articles from Al Ibtida: Jurnal Pendidikan Guru MI.
2. All the served data or quotes in the article taken from the other author articles should attach the reference sources.
3. Writing citations and bibliography should use application management references such as Mendeley, End Note, Zotero or applications in Ms Word.
4. Writing citations and bibliography using APA format (American Psychological Association) by using innote writing technique.
5. All references used must be taken from the main source (scientific journal and at least 80% of the reference amount used).
6. Number of references at least 25 references.
7. References used should be published in the last 10 years.
8. Wikipedia, personal blog, and non scientific website are not allowed to be used as reference.
